

# Roxsand

## 30 CFR Part 60 - Respirable Crystalline Silica

The description above is the name of MSHA's new policy on respirable silica dust, which has been in the works for several years. This policy effectively reduces the permissible exposure levels for miners by 50%.

The final rule took effect on June 17, 2024. Coal Mine operators have 12 months to achieve compliance with the final rule's requirements, while Metal/Nonmetal Mine operators have 24 months. L. G. Everist has been proactive in reducing or eliminating exposure to respirable dust through engineering and administrative controls, as well as personal protective equipment. The new silica regulation will require us to continue to evaluate and assess all areas of our plants, including heavy equipment, focusing on the new silica standard to ensure we are in full compliance by April 8, 2026.

With the extension of the surge tunnel and additions of a Sandvik Jaw Crusher and two 400 Series Cone Crushers, we have upscaled our dust control measures. At the secondary plant, we have installed a dust suppression system that allows us to customize our approach and focus on the

on areas that could create a respirable dust hazard, such as underneath the cone crushers. On the discharge end of the crushers, we installed covers with skirting over the belts and added a mister to knock down the airborne dust.

As with other locations, we use water trucks at the start of the crushing process, spraying the shot rock before it is put in the jaw. We also have an external water tank to run water to the discharge belt on its way to the surge pile. The water trucks are also used for watering all of the roads on the mine site. We have three water trucks between the two Dell Rapids quarries, which allows us a backup in case one of the trucks requires maintenance or is out of service.

The new ruling will be a challenge for all of us. However, embracing this challenge is crucial for our safety, which is why we are committed to meeting it head-on. We are committed to the safety of our team members and believe that by evaluating and assessing our processes, procedures, and equipment, we will be able to comply with the new standard. This is all possible because we have a rock-solid team.

Lastly, in the fourth photo, the application of water on quarry roads is utilized for dust control.
